- Fair Hours: 8:00 am to 9:00 pm each day (Saturday ends around 5 PM). Vendors are welcome to set their own work hours to accommodate usage of volunteers, staff, and peak sales hours.
- Set-Up: Tuesday, August 9<sup>th</sup> from 9:00 AM to 8:00 PM
- Tear-Down: Saturday, August 13<sup>th</sup> from 5:00 PM to 8:00 PM
- Booth Size: Outside – 20' x 20' (some exceptions allowed)  
Inside – 8' x 10'
- Booth Fee: \$50.00 plus electricity (non-food) for the 4-day Fair.
- Electricity: \$20.00 per hook-up
- Insurance: Proof of liability must be submitted with contract and payment or your booth request will be refused. You must carry a minimum of \$500,000 liability with Baker County Fair/Baker County as additional named insured. Your insurance company will be happy to provide this, and they may fax this to us at 541-524-9567.
- Admission: This year we are offering a free fair.
